

# PMI Eligibility and Guideline Changes

## Effective 2.20.09

### Ineligible

- Manufactured Housing
- Construction-to-Permanent
- 2-unit properties
- Interest Only
- Third Party Originations
- Nontraditional credit

### Credit Score

- Minimum 680 credit score will be required on all products and programs, with the exception of High Balance loans

### High Balance Loans

- Minimum 740 credit score
- Minimum initial fixed period of 5 years on all ARM loans
- Maximum 3% Interested Party Contributions

#### Ineligible

- Loans with temporary buydowns
- Balloon mortgages
- Loans for properties in Arizona, California, Florida, Hawaii, Nevada and Rhode Island

### Condominiums & Co-ops

- Maximum 90% LTV

### Debt-to-Income Ratio

- Maximum 41% Debt-to-Income ratio; compensating factors will not be considered

### Appraisal Requirements

- Reduced appraisal forms are ineligible, such as those that are DU®/LP-driven (e.g., Exterior-Only 2055, drive-by inspection, and Property Inspection Waivers/Alternatives)

Please note the following PMI Distressed Markets Policy/List changes supersede the previously scheduled revisions effective 3.1.09:

### PMI Distressed Markets Policy

- Maximum 90% LTV for all distressed markets
  - Maximum 85% LTV for condominiums & co-ops
- Minimum 700 credit score for all distressed markets
  - Minimum 720 credit score for properties in AZ, CA, FL, HI, NV and RI
- Minimum initial fixed period of 5 years on all ARM loans
- Maximum 3% Interested Party Contributions
- Attached Housing in the state of Florida is no longer eligible (this includes condominiums, attached PUDs, co-ops, 2- to 4-units, townhomes, and row houses)
